Nomination Guidelines

Life Membership is the highest award the Association can bestow and is presented sparingly and only to those who have made significant, quality and sustained contribution towards the growth and success of the Association, above and beyond the normal expectations of any position they may have served in.

- Information detailed needs to relate specifically to the nominee's RFSA service. Nominees must have been an appointed RFSA representative for a minimum, but not necessarily consecutive, eight (8) year period.
- Reading of the relevant award policy is recommended before completing the nomination form. A copy of the associated policy is available on the RFSA website (www.rfsa.org.au) or by request from the RFSA Office.
- It is the responsibility of the Member(s) submitting the nomination to provide complete and relevant information in support of the nomination.
- Nominations must be on the official RFSA nomination form and can be submitted via email or post.
- When attaching additional/supporting documents the pages must be labelled identifying the relevant section i.e. 1.1, 1.2, 1.3 etc.
- The Honours and Awards Committee reserves the right to verify and/or seek further information on statements made on the nomination form.
- Late nomination forms will not be accepted.
